# **ACADEMIC ADVISING AND REGISTERING FOR CLASSES**

All second degree online nursing students will register through their CAMS student portal or through their academic
advisor. A representative from the Office of the Registrar will be present during the registration day program to
walk through the registration process. Site directors and nursing advisors will also be present to answer questions
specifically about the nursing curriculum. A representative from Marian's Adult Program (MAP) will also be present
to answer any questions about the scheduling of remaining co-requisites through MAP.

- Students who have an outstanding balance at the time of registration will not be registered until all financial holds have been cleared with the Business Office.
- NO LATE REGISTRATION: Students <u>must</u> be registered in their CAMS Student Portal <u>by Sunday, January 8th @ 11:59pm</u> or they will <u>not</u> be able to start classes for the spring semester. CAMS Student Portal will be available for online registration through <u>Sunday, January 8th @ 11:59pm</u>. Students who are not registered before this time will fall out of progression.

## **CLASS CANCELLATION OR CHANGE**

The university reserves the right to change or cancel courses as needs and enrollment warrant. Because course information may change in between registration and the first day of classes, students should print an updated schedule from their CAMS student portal immediately prior to the start of the classes.

# SCHEDULES FOR WITHDRAWAL FROM THE UNIVERSITY and REDUCTION OF CHARGES:

A student who withdraws from school may be entitled to full or partial reduction of charges. Reduction of charges is based on the official date of withdrawal as recorded in the Office of the Registrar. Consult with the Financial Aid Office concerning the impact that withdrawal may have upon current financial aid awards.

## Standard (semester-long) courses

- withdraw on or before January 13 = 100%
- withdraw January 17-January 20 = 90%
- withdraw January 23-January 27= 60%
- withdraw January 30-February 3 = 25%
- withdraw on or after February 6 = 0%
- last date to withdraw from individual courses with a "W" grade – March 24

# Courses lasting 5 weeks or more (up to, but not including, semester-long courses)

- withdraw during calendar week 1 = 100%
- withdraw during calendar week 2 = 50%
- withdraw during calendar week 3 or after = 0%
- last date to withdraw from individual courses with a "W" grade – end of calendar week 2

Courses lasting 4 or fewer weeks - no "W" grades given without complete withdrawal from the university

• withdraw prior to start of class = 100%; withdraw after class begins = 0%

If you discontinue a class without following proper withdrawal procedures, you will receive a failing grade. To withdraw from an individual class, contact your advisor or Director of Nursing Education; a \$50 change in registration fee will be assessed. To withdraw from all classes for the semester (withdraw from the university), contact the Office of the Registrar.

Failure to notify the Office of the Registrar may mean that university publications, such as team rosters or student directories, may include some directory information.
